We invite you all to come and provide your valuable contribution with the aim to generate common ideas focusing on this transcultural challenge.

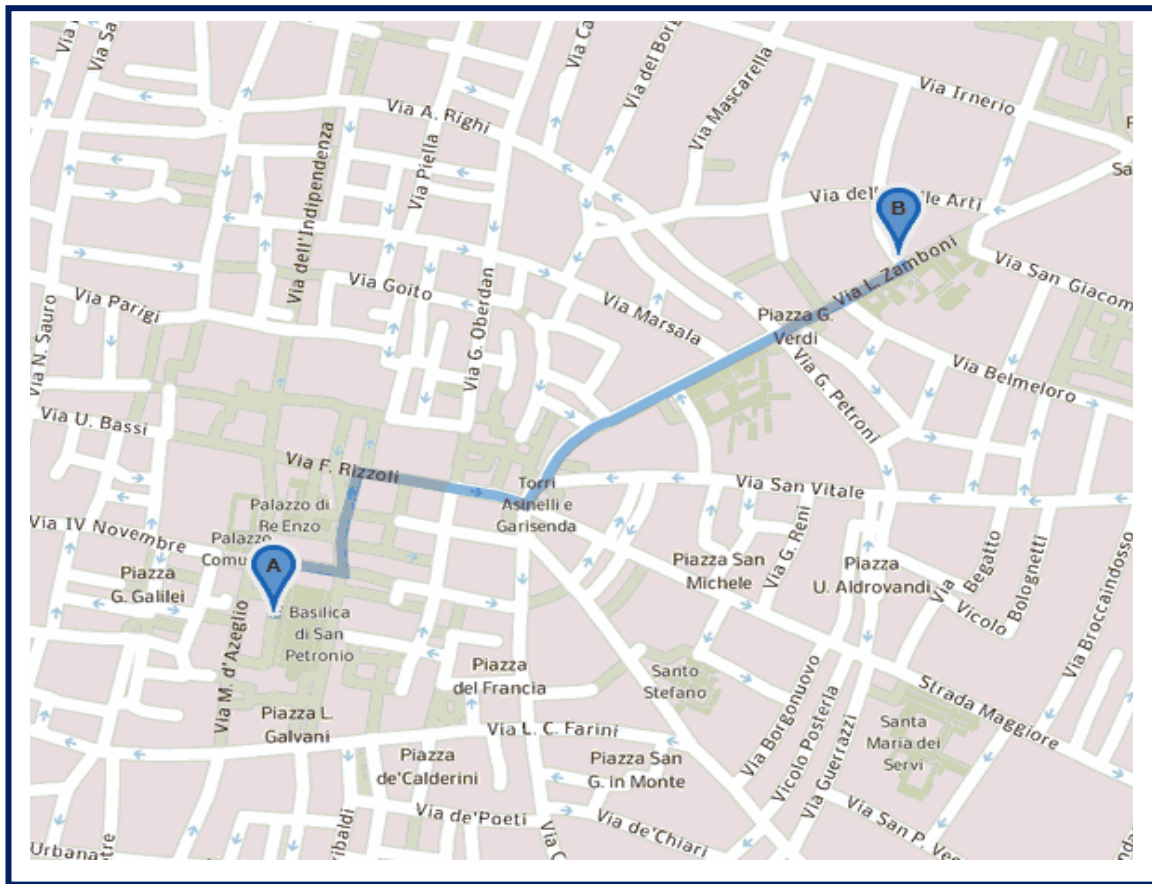

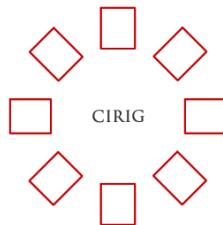
